DEFINITIONS:

Class Days are regular instructional days. **Test Days** are used for final exams or other end-of-term instructional or professional activities. **Duty Days** are when faculty members engage in duties as assigned by the administration. **Faculty Contract (FC) Days** are used by faculty for activities necessary for the successful accomplishment of their professional responsibilities. These may be **Fixed FC Days** (designated on specific days) or **Float FC Days** (self-scheduled, flexible).

[These definitions are drawn or derived from the MSCF Contract, Articles 2 and 10, and intended to be compatible with standard interpretations of contract definitions as well as the description of faculty work assignments in Article 11.]

NOTES:

Official Course Withdrawal shall be established as the date on which eighty percent (80%) of the instructional days for the course have elapsed.

Classes in Summer Session shall have flexible start dates and shall not exceed 39 consecutive days.
