# **Paramedic Courses Application Form**

#### **Program Entrance Requirements**

All students accepted into the Paramedic Program must comply with all entrance requirements prior to the start of the fall semester. Students who have met these requirements at the time of application will receive priority placement. Students who have not yet met these requirements but anticipate meeting them may receive placement contingent on completion. If these requirements have not been met prior to the start of the fall semester, the student will be removed from paramedic courses.

#### **General Education Requirements**

All applicants accepted into the program must have completed the following courses with a "C" or above by the end of the summer semester preceding fall semester enrollment of program specific courses.

- Anatomy and Physiology I
- Anatomy and Physiology II

- Ambulance BLS ride along\*
- EMT Basic\*

All applicants must also have the following licensure, current and in good standing, by the end of the summer semester preceding fall semester enrollment of program specific courses.

#### **Advanced Placement and Experiential Learning Policies**

Northland Community and Technical College does have a policy for Advanced Placement of students. The student makes application for advanced standing with the Student Development Division. The student must provide official transcripts to validate previous educational experience. A transcript review committee evaluates each application for advanced standing prior to enrollment of the student in a given semester. Students are notified if the previous educational experience is deemed to meet requirements and exemption from that course work is acknowledged.

### Paramedic Program Courses - Limited Advanced Placement

Transfer credits for the required general education courses follow the rule of advanced placement as stated above.

Due to the sequential nature of all paramedic didactic and clinical courses, as well as limited number of students, the Northland paramedic program limits acceptance of transfer credits to EMT Basic and BLS Ambulance Ride Along. These will be reviewed by the academic advisor and Paramedic Program Director on a case-by-case basis. Students must submit proof of current NREMT EMT licensure and provide a letter of recommendation from current employer or squad leader that verifies experience with direct patient care in a prehospital setting.

Northland's Paramedic program does NOT accept advance placement of program specific course work or clinical experience from any other paramedic program. With the exception of the above listed courses, if an individual that has completed credits from another paramedic program and intends to apply to the Northland paramedic program, they must apply for selection as all other applicants and complete all paramedic courses and clinical in the same curriculum sequence.
