## 3340P ASSESSMENT FOR COURSE PLACEMENT PROCEDURE

Multiple Measures Assessment are the evaluation tools used for student placement into appropriate college courses.

The evaluation indicates whether a student has met evaluation criteria for college level Math and/or English. "College level" refers to a student's preparedness to succeed in college-level coursework helping them to progress toward their degrees efficiently.

If a student does not meet the required standards across the evaluation criteria, an assessment hold will be placed. This hold remains until the student either completes guided self-placement with their advisor or takes the Accuplacer assessment. Once these steps are completed, the hold will be lifted.

When ACT, SAT, MCA and high school GPA scores are available, they will be considered first, and the student will be advised about their placement options. ACT, SAT and MCA scores are valid for 5 years inclusive of the current calendar year. Accuplacer scores are valid for five calendar years, inclusive of the current calendar year, for reading and writing and within two calendar years, inclusive of the current calendar year, for mathematics. A cumulative high school GPA of 2.8 or higher and the completion of Algebra II with an average of C- or better is college level ready in math. A cumulative high school GPA of 2.6 or higher is college ready in reading/writing. High school transcripts and/or GED are valid for 10 years.

Circumstances which may exempt students from all or portions of the assessment may include:

- Completion of an associate degree, Baccalaureate degree or higher degree
- Documentation of successful completion of a college-level course in the area for which the course placement score is used
- Enrollment in courses or programs specifically designed as customized training, continuing education or management education programs
- Enrollment in one- or two-course program of study
