## 1. Determine Eligibility

You are considered an independent student for financial aid purposes if you meet any ONE (or more) of the following criteria at the time you first completed and signed your 2023-2024 FAFSA.

- You were born before January 1, 2000
- You are married
- Both of your biological or adoptive parents are deceased
- You are a veteran or active duty in the U.S Armed Forces
- You have a child or children for whom you provide more than 50% support
- You have dependents who live with you and receive more than 50% support from you
- You are admitted into a master's or doctorate program
- You were a ward of the court or in foster care at any time from age 13 or older
- You were declared by a court in your state of residence to be an emancipated minor

If you do not meet any one of the criteria mentioned above, you can NOT be considered Independent if:

- Your parents are unwilling to assist you financially
- You consider yourself financially independent from your parents
- You live in a different residence than your parents
- Your parents are unwilling to provide information during the application process
- You are in a disagreement with your parents
- You claim yourself on your federal income tax return (or your parents do not claim you on theirs)

While these circumstances may commonly indicate the independence of an individual, the United States Department of Education has specifically stated they do NOT qualify a student for Independent status. Schools are prohibited from granting a dependency override on these conditions.
